BID NOTICE UNDER OPEN BIDDING

Standard Invitation to Bidders

KIRA/GKMA/WRKS/2023-2024/00014/1/2/3

- 1. The Government of Uganda** through the Ministry of Kampala Capital City and Metropolitan Affairs (MKCC&MA) has received funding from the **World Bank/International Development Association (IDA)** to implement **the Greater Kampala Metropolitan Area-Urban Development Program (GKMA-UDP)**. Kira and **Mukono Municipalities** as the participating entities have been allocated funds under the program for the Upgrading and Reconstruction of selected roads to bituminous standards. Kira Municipality has been selected as the Lead Procurement and Disposing Entity for this procurement under Batch 1a.
2. Kira Municipal Council invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding shall be conducted in accordance with the procedures contained in **the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) – Order 2021** and the Regulations made under the Act, and is open to all eligible bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding document **at the address given at 7(d) from 8:00 am to 5:00 pm.**
5. Bidding Documents in English may be purchased by interested bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of **UGX 300,000** (Three Hundred Thousand Shillings) only, per Lot. The method of payment will be by obtaining a payment reference number (PRN) after which a general receipt shall be issued from Kira Municipal Council.

The bidding document shall be issued by the Procurement and Disposal Unit (PDU) upon presentation of the general receipt at the address given at 7(d). Bids must be delivered to the address at 7(d) on or **before 04th April 2024, 11:00 am**. All bids must be accompanied by a bid security of Uganda Shillings: **(please refer to the table below)**.
